When you rent self-catering accommodation in France the rule is that you leave it as clean as you found it and without damage. This deposit is held until you vacate the mobile and it has been checked. A minimum of **£70** will be deducted from the deposit if it is not properly clean, and requires cleaning. Further deductions may be made to cover damages or loss of inventory. If all is in order, the deposit will be returned within 14 days of you vacating. If, before full payment, you should CANCEL your booking the deposit will be retained. If you should cancel after full payment, only the deposit will be refunded. However, if we are able to re-book, then all except an administration fee of £50 will be refunded.
